



# Extract from Resolution No. 318/2016 of the CEO of the Budapest Stock Exchange Ltd

Budapest, 15 July 2016

The Chief Executive Officer of the Budapest Stock Exchange (hereinafter: Exchange) declares that orders for shares of **Norbi Update Lowcarb** Plc. (ISIN: HU0000128103, registered seat: 1031 Budapest, Záhony utca 7/c., hereinafter: Issuer) subject to the limitations set by the General Terms of Service of the Budapest Stock Exchange Ltd. Book five – Regulations on Trading (hereinafter: Regulations on Trading) under section 13.3.4, on the exchange day of 18 July, 2016 will be modified to:

- bid prices may be up to 50% higher than the Reference price;
- offer prices may be up to 50% lower than the Reference price.

## Reason

The Exchange has considered that in UPDATE1 shares the price movement limitations - set by the Regulations on Trading under 13.3.4 and CEO Resolution 550/2013 - are considered as insufficient for the following day's exchange trading.

Therefore, in order to ensure the smooth flow of trading the CEO of the Exchange decided accordingly.
