Resolution No. 11/2017. of the Board of Directors of the Budapest Stock Exchange Ltd.

The Board of Directors of the Budapest Stock Exchange Ltd. passes the resolution hereunder, concerning the amendment of the latest amending Resolution No. 38/2016 of the Board of Directors governing the power of representation and the right to sign – taking into consideration the relevant provisions of law, the Articles of Association and The Regulation of Budapest Stock Exchange Ltd. Regarding Organisational and Operational Rules (hereinafter as: OOR) – in a consolidated form with the previous amendments.

With regards to the defined group of affairs, the Board of Directors entitles employees of the Budapest Stock Exchange Ltd. (hereinafter as: Company) with power of representation, and, within the frame of the power of representation, with the right to sign as follows:

1. GENERAL RULES

Any two of the hereunder specified employees of the Company shall be entitled to jointly exercise the right to sign on behalf of the Company, as stipulated in this Resolution.

- 1.1. The employees authorized to sign on behalf of the Company shall be entitled to exercise their right primarily regarding their responsibilities as stipulated in the OOR.
- 1.2. In the absence of an employee authorized to sign on behalf of the Company, other employees authorized to sign on behalf of the Company shall be obliged and entitled to exercise the right to sign as a substitute, according to the OOR's provisions regarding the order of decision-making.
- 1.3. In the course of exercising the right to sign on behalf of the Company, close relatives as defined by the Act CXX of 2001 on the Capital Market may not exercise joint power of representation Company.
- 1.4. The power of representation regulated by this resolution shall not cover the exercising of employers' rights which is regulated under the OOR.

Any two of the hereinabove specified employees of the Company shall be entitled to jointly exercise the power of representation, in the first place in connection with their responsibilities as stipulated in the OOR. In the absence of an employee entitled to the power of representation, other employees entitled to the power of representation regarding other responsibilities shall act as a substitute, under the OOR's order of decision-making provisions.
