



**Resolution No 263/2018 of the Chief Executive Officer of
the Budapest Stock Exchange Ltd.**

The Chief Executive Officer of the Budapest Stock Exchange Ltd. (hereinafter referred to as 'Exchange') **suspends exchange trading in the ordinary shares (ISIN: HU0000088760) and related derivate instruments (included in the Annex to this Resolution) of the issuer Budapesti Ingatlan Hasznosítási és Fejlesztési Nyilvánosan Működő Részvénytársaság (székhelye: (registered seat: HU-1033 Budapest, Polgár u. 8-10.) – hereinafter referred to as 'Issuer' – on September 11, 2018 from 08:25 a.m. to the end of the Exchange Day – until the end of the 'Post Trading phase' – on September 11, 2018.**
