Due to share transfers ESSENCE INVEST Korlátolt Felelősségű Társaság acquired 219.019 pieces of MASTERPLAST ordinary shares and voting rights attached to MASTERPLAST ordinary shares, the proportion of voting rights is 1, 50 %, and Firmum Capital Korlátolt Felelősségű Társaság acquired 219.019 pieces of MASTERPLAST ordinary shares and voting rights attached to MASTERPLAST ordinary shares, the proportion of voting rights is 1, 50 %.
