



Extraordinary Announcement of 4iG Plc.

on the new debt settlement plan of Space-Communications Ltd.

4iG Public Limited Company (“4iG”) hereby informs the participants of the capital market that on the 9th of April 2024 the Board of Directors of 4iG has prepared a proposal with two possible outcomes, for debt settlement plan to settle Space Communications Ltd.’s (registered seat: 7 Menachem Begin St., Ramat Gan, Israel; company registration number: 51-139604-6; hereinafter referred to as: “Spacecom”) – a company of which the minority shareholder is 4iG by owning 20% of its shares – full bond debt service towards its bondholders.

In case of approval of the proposal under the new debt settlement plan:

- a) 4iG would transfer USD 150,000,000 (one hundred and fifty million USD) to Spacecom, in consideration for the sale and purchase of AMOS-17 satellite owned by Spacecom and the leaseback of the satellite by Spacecom or,
- b) 4iG would transfer USD 150,000,000 (one hundred and fifty million USD) to Spacecom in a form of a loan.
