OTP Bank Plc. announces that – according to the Resolution No. 10/2023 of the Annual General Meeting on 28 April 2023, as a part of implementing the Bank’s remuneration policy – on 15 April 2024 the Bank purchased 30,831 own shares at an average price of HUF 17,721 per share on the Budapest Stock Exchange, with the contribution of OTP Bank as investment service provider.

Due to the transaction the stock of own shares owned by the OTP Group has been changed to 1,859,234 shares. The stock of own shares is 0.66%.
