








**4. table: Transactions executed on the spot market via Internet in proportion of households' turnover  
(January - September, 2021)**










8. table: Breakdown of equity turnover by investor categories (January - September, 2021)




9. table: Breakdown of derivatives turnover by investor categories (January - September, 2021)




10. table: Spot market turnover breakdown by investor categories (September, 2021)
























**22. table: Single equity based futures contract turnover breakdown by investor categories  
(September, 2021)**










