

MASTERPLAST – INFORMATION ABOUT INVESTING

On June 3, 2019 Masterplast (Company) acquired a 24% stake in T-cell Korlátolt Felelősségű Társaság while the remaining 38-38% of the company was purchased by Zsolt Sinkó and Dr. Marcell Lakatos as financial investors. The main activity of T-CELL KFT is polystyrene producing in two Hungarian plants – in Hajdúszoboszló and Zalaegerszeg – that can annually produce 300.000 m³ EPS per annum. The company has a market share of around 10%.

According to the Company, the revenue and earning addition from the announced Masterplast acquisition is expected in the second half of this year. With this collaboration, Masterplast's existing manufacturing background will be further strengthened. Masterplast can support the company with its existing manufacturer knowledge base, raw material supply, and distribution and logistics background.

The acquisition can help Masterplast in the following areas

- T-cell will buy the raw material for the production of thermal insulation from the Masterplast, which will result in a large, but low margin increase in revenue for the Company.
- T-cell manufacturer's product background can further strengthen Masterplast's sales and results.
- Capacity increase and favourable manufacturer logistic capabilities can help Masterplast.

The purchase price is not public

Last year's net profit for T-cell was negative, but the company was profitable in preceding years. The company's EBITDA in 2017 was HUF 207 million - based on this figure and an EBITDA multiplier of 6-7, the value of the company could be between HUF 1.24 and 1.45 billion. As Masterplast acquired a 24% share in T-cell Kft., Masterplast could have paid an amount of between HUF 298-348 million (EUR 0.93-1.08 million), according to our calculations. The Company's cash and equivalents stood at EUR 1.9 million at the end of Q1 2019.

Summary

The acquisition can be clearly evaluated as a positive step, which also fits into the company's strategy. The acquisition might help to achieve the targets set out in its strategic plans. The trends and industrial climate in the Company's certain relevant markets are expected to remain favourable in the coming quarters. **The target price is currently under review, we will soon publish our updated model.**

Methodology used for equity valuation and recommendation of covered companies

The discounted cash flow valuation is a method of valuing a company (or project, assets, business, etc.) with the time value of the money. The model forecasts the company's free cash flow (free cash flow to firm) and discounts it with the average cost of capital (WACC). The cash flow is simply the cash that is generated by a business and which can be distributed to investors. The free cash flow represents economic value, while accounting metric like net earning doesn't. The WACC r

represents the required rate of return by the investors. If a business is risky the required rate of return, the WACC will be higher.

Discounted cash flow model (DCF): We analyze the companies using five year forecast period and set a terminal value based on the entity's long term growth or on different exit multiples like EV/EBITDA or EV/EBIT. In certain cases the forecast period may differ from five years. In this case the analysts must define the reason for difference. The cash flows are discounted by the company's WACC unless otherwise specified.

In the first step we have to forecast the company's cash flow. The free cash flow to firm (FCFF) is based on the earnings before interest and taxes (EBIT), the tax rate, depreciation and amortization (D&A), net change in working capital (which is based on the current assets and current liabilities) and the capital expenditures (CAPEX). The model requires a terminal value which can be based on the long term growth or on an exit multiple like EV/EBITDA, or EV/EBIT. Forecasting the terminal value is a crucial point because in most cases it makes up more than 50% of the net present value.

The discount rate (WACC): The average cost of capital of the company is dependent on the industry, the risk free rate, tax, the cost of debt and the equity risk premium. The cost of equity is calculated by the CAPM model, where the independent variables are the risk free rate, the industry specific levered beta, and the equity risk premium. The WACC is dependent on the capital structure, so the forecast of the equity/debt mix is crucial.

At the end we get the enterprise value (EV). The EV is the market capitalization plus the total debt and preferred equity and minority interest, minus the company's cash. In the last step we have to reduce the EV with the net debt. This figures divided by the shares outstanding we arrive at the target share price.

The discounted cash flow model includes sensitivity analysis which takes the effects of the change in the WACC, the long term growth or the used exit multiples on which the terminal value is based.

Our target price is based on a 12 month basis, ex-dividend unless stated otherwise.

Peer group valuation: For comparison we use peer group valuation. The analysis based on important indicators and multiples like P/E, EV/EBITDA, EV/EBIT, market capitalization, P/S, EBITDA margin, net debt to EBITDA, EBITDA growth, dividend yield and ROIC. If the industry justifies we may use other multiples. The peer group is compiled according to the companies' main business, with respect to the region (DM or EM market).

Recommendations

- Overweight: A rating of overweight means the stock's return is expected to be above the average return of the overall industry, or the index benchmark over the next 12 months.
- Underweight: A rating of underweight means the stock's return is expected to be below the average return of the overall industry, or the index benchmark over the next 12 months.
- Equal-weight: A rating of equal-weight means the stock's return is expected to be in line with the average return of the overall industry, or the index benchmark over the next 12 months.
- Buy: total return is expected to exceed 10% in the next 12 months.
- Neutral: Total return is expected to be in the range of -10 - +10% In the next 12 months.

- Sell: Total return is expected to be below -10% in the next 12 months.
- Under revision: If new information comes to light, which is expected to change the valuation significantly.

Change from the prior research

Our first research was published on 15 December 2017. In that Initial Coverage our price target was HUF 775, but the changes in fundamental factors justified the update of our model. The target price is currently under review, we will soon publish our updated model.
